Approval of Minutes: Minutes from the October 2020 meeting were approved as written.

#### Presentation:

- Kandy Kelley, PC Coroner
- Coroner for 12 years; Deputy for 8 years prior •
- Must Determine: Cause (Medical) & Manner (Mechanism) of death •
- Doctors can only sign on Medical deaths •
- Coroner serves death notification •
- Completes subpoenas doesn't need a judge to issue these •
- Proactive in trying to save lives; PC is number 1 in the state for suicide •
- PC is known for making good meth resulting in working many overdoses •
- On-Scene response: •
  - EMS calls the coroner after testing
  - Scene then belongs to the coroner; not police
  - If body is tampered with, they can be charged
  - Coroner responds and enters when scene is safe
  - Documents what is seen 0
  - Determines if there is a need for an autopsy (Greenville) 0
- Immediate response; 1 deputy (8 days a month)

- Coroner will call OSHA if it is a workplace fatality
- If called to a plant, she will want to speak with a supervisor then others as necessary
- Clemson University has developed a program to compile their statistics back to 1976; can get data as needed
- Releases information to the media via a new release after notification. Release is then sent to reporters
